**Chapter 70, ALARMS**

§ 70-9. Sale, lease or furnishing of alarm system.

F. All alarm users **shall obtain an alarm user's permit** for each premise from the coordinator's office upon the effective date of this chapter or prior to use of an alarm system. An application for the alarm user's permit and a fee, to be determined by the Board of Supervisors from time to time by resolution, will be filed with the coordinator's office. Each alarm permit shall be valid for the life of the alarm system or until the premise where such alarm is located is sold. It shall be the responsibility of the new owner to make application for a new permit. (sixty-five (65) years or older CAN OBTAIN PERMIT WITHOUT FEE)

**§ 70-10. False alarm.**

A. Any alarm system which has **more than two (2) false alarms within a permit year** shall be subjected to penalties and provisions as provided under § 70-12.

**§ 70-11. Enforcement authority.**

B. The coordinator or his designated agent, in lieu of filing a citation or commencing any other **proceedings against any person violating the provisions of this chapter may, provide the opportunity to any offender to pay a fee of twenty-five dollars (\$25.)** The coordinator and/or his designated agent shall adopt such rules and regulations as are appropriate related to notice to potential violators of their option to pay a fee in lieu of the township proceeding with a prosecution.

**§ 70-12. Violations and penalties.**

B. Any alarm user, whether person, firm, partnership, association, corporation, company or organization of any kind in control of a premises wherein an alarm system is maintained, violating § 70-10, shall be sentenced, if convicted, to a fine of not more than one thousand dollars (\$1,000.) and costs of prosecution and reasonable attorney's fees.
